Provided below is information for the transportation of firearms and ammunition for airline travel.

AS STATED IN JULY 2008

Most airlines have provided a link to the specific web pages for Baggage Allowances, Carry-on Baggage information, Firearms and Ammunition, Restricted Articles and Specialty Items of which can include but is not limited to antlers, game meats and fishing equipment.

The TSA website is truly the end all be all for airline travel regulations. Canadian and European transportation agencies have essentially the same regulations and generally defer some of their information to the TSA. Before starting any research for your flight it is imperative that you thoroughly look at the TSA website because they have the broadest amount of information and they are the supreme authority.

When traveling internationally, here are three issues by most if not all of the airline carriers:

- 1) The airlines have stated that their policy for transporting firearms is the same for both domestic and international flights.
- 2) They advise that you call the airline desk at your departure airport to inform them that you are flying with a firearm and to get the most up-to-date information on procedures at that airport.
- 3) If you are transferring from one airline to another, it is imperative for you to call the second airline to check if they have any additional regulations, especially if your transfer is in an international airport. There may be additional permits or procedures to be processed prior to your arrival.
- 4) Certain temporary visitor permits are required if you are planning on staying overnight in an international location that is not your final destination. Contact your airline provider to discuss arrangements for your firearm.

General overview of regulations

Firearms can be included as your free baggage allowance if they meet the required criteria:

- 1. Declared at the ticket check-in counter
 - a. Precludes one from using curb check-in, E-check-in, Automated, pre and phone check-in
 - b. Declaration must be done at the ticket counter
- 2. Firearm must be unloaded
- 3. Must be in a hard sided case
- 4. Container must be lockable with either a key lock or a combination lock
 - a. Do not have container locked when declaring
 - b. TSA agent will need to open and verify the firearm is unloaded
 - c. All→ALL locks must work properly
 - d. Good idea to bring duct tape to further secure any questionable locks

- 5. Must provide key or combination to screener to open container and you must remain present during the screening process
- 6. Ammunition must be securely packed in ammo specific packaging
- 7. Ammunition may be located in the same hard-sided case as the firearms, but it must remain in its ammo specific packaging
- 8. Black powder, loose gunpowder and firing caps are prohibited as both carry-on and checked baggage
- 9. As a rule airlines will allow for 5kg of ammunition to be transported on the plane, 5kg is approximately 10.5 to 11 pounds.

Archery Equipment:

Prohibited from being a carry on item

1 Bow and 25 Arrows tends to be the rule for air-carriers

Must be securely wrapped and packaged to that they do not cause damage to personnel or luggage

Angling and fishing equipment:

Angling and fishing equipment is allowed as part of your checked luggage provided that it is properly packaged and any sharp hooks are secured. The container cannot exceed any normal luggage dimensions or else a handling charge will be added on. Typically \$150.00. Some airlines will permit one to bring fragile rods provided they are broken down and in a case. Most also suggest that if reels are fragile then they should be carried as part of your carry-on baggage.

Hunting Equipment

Firearms and Ammunition - Firearms, ammunition and firearm parts may only be transported in checked baggage. Firearms, ammunition and firearm parts are prohibited from carry-on baggage.

There are certain limited exceptions for law enforcement officers (LEOs) who are authorized to fly armed by meeting the requirements of 49 CFR § 1544.219.

Following is a summary of key regulatory requirements to transport firearms, firearm parts or ammunition in checked baggage:

- All firearms must be declared to the air carrier during the ticket counter check-in process.
- The firearm must be unloaded.
- The firearm must be carried in a hard-sided container.
- The container must be locked.

- The passenger must provide the key or combination to the screener if it is necessary to open the container, and then remain present during screening to take back possession of the key after the container is cleared.
- Any ammunition transported must be securely packed in fiber (such as cardboard), wood or metal boxes or other packaging specifically designed to carry small amounts of ammunition.
- Firearm magazines/clips do not satisfy the packaging requirement unless they provide a complete and secure enclosure of the ammunition (e.g., by securely covering the exposed portions of the magazine or by securely placing the magazine in a pouch, holder, holster or lanyard).
- The ammunition may also be located in the same hard-sided case as the firearm, as long as it is properly packed as described above.
- Black powder and percussion caps used with black-powder type firearms are not permitted in carry-on or checked baggage.

The regulations are strictly enforced. Violations can result in criminal prosecution and the imposition of civil penalties of up to \$10,000 per violation.

Air carriers may have their own additional requirements on the carriage of firearms and the amount of ammunition an individual may place in checked baggage. Therefore, travelers should also **contact the air carrier regarding its firearm and ammunition carriage policies.**

If you are traveling with a gun or ammunition, please read our information on traveling with these items for more information.

Bow and Arrows - Bows and arrows are prohibited from carry-on luggage. These items should be packed in checked luggage. Any sharp objects packed in checked luggage should be sheathed or securely wrapped to prevent injury to baggage handlers and security screeners.

Hunting Knives and Tools – Hunting knives and certain tools are prohibited from carry-on luggage. These items should be packed in checked luggage. Any sharp objects packed in checked luggage should be sheathed or securely wrapped to prevent injury to baggage handlers and security screeners.

Fishing Equipment

Fishing Rods / Poles - Fishing Rods are permitted as carry-on and checked baggage. However, please check with your air carrier to confirm that it fits within their size limitations for carry-on items. Ultimately, it is the carrier's decision as to whether or not it can be transported as carry-on baggage.

Spear Guns - Spear guns are prohibited from carry-on luggage. These items should be packed in checked luggage. Any sharp objects packed in checked luggage should be sheathed or securely wrapped to prevent injury to baggage handlers and security screeners.

Tackle Equipment - Fishing equipment should be placed in your checked baggage. Some tackle equipment can be considered sharp and dangerous. Expensive reels or fragile tackle such as fly's should be packed in your carry-on baggage.

There are certain limited exceptions for law enforcement officers who may fly armed by meeting the requirements of <u>Title 49 CFR § 1544.219</u>. **Law enforcement officers** should read <u>our policies on traveling</u> with guns.

The key regulatory requirements to transporting firearms, firearm parts or ammunition in checked baggage are:

- You must declare all firearms to the airline during the ticket counter check-in process.
- The firearm must be unloaded.
- The firearm must be in a hard-sided container.
- The container must be locked.
- We recommend that you provide the key or combination to the security officer if he or she needs to open the container. You should remain present during screening to take the key back after the container is cleared. If you are not present and the security officer must open the container, we or the airline will make a reasonable attempt to contact you. If we can't contact you, the container will not be placed on the plane. Federal regulations prohibit unlocked gun cases (or cases with broken locks) on aircraft.
- You must securely pack any ammunition in fiber (such as cardboard), wood or metal boxes or other packaging that is specifically designed to carry small amounts of ammunition.
- You can't use firearm magazines/clips for packing ammunition unless they completely and securely enclose the ammunition (e.g., by securely covering the exposed portions of the magazine or by securely placing the magazine in a pouch, holder, holster or lanyard).
- You may carry the ammunition in the same hard-sided case as the firearm, as long as you pack it as described above.
- You can't bring black powder or percussion caps used with black-powder type firearms in either your carry-on or checked baggage.

Passengers will be permitted to bring liquids, gels and aerosols through security screening at Canadian airports provided that the items are packaged in containers with a capacity of 100 ml / 100 grams (3.4 oz) or less, and that the containers fit comfortably in one clear, closed and resealable plastic bag with a capacity of no more than 1 litre (1 quart). The approximate dimensions of a one litre/quart bag are 15.24 cm by 22.86 cm (6 in. by 9 in.) or 20 cm by 17.5 cm (8 in. by 7 in.). One bag per passenger will be permitted.

Firearms, Real Ammunitions and Cartridges

Firearms, real ammunition and cartridges are not permitted in carry-on baggage under any circumstances. Certain may be transported in checked baggage if properly packaged and approved by the air carrier. All firearms, ammunitions and cartridges must be declared to the air carrier during check-in process. For more details on how to transport these items in your checked baggage, please contact your air carrier.

Boxed cartridges: With the approval of the operator(s), passengers may bring securely boxed cartridges as checked baggage only, for sporting purposes, in quantities not exceeding 5 kg (including box and packaging) per person for that person's own use. Ammunition with explosive or incendiary projectiles is prohibited. Allowances for more than one per person must not be combined into packages over 5 kg

Crossbows (including arrows and darts) are not permitted in either carry-on or checked baggage under any circumstances.

Bows and arrows for sporting use are not permitted in carry-on baggage under any circumstances. They may be transported in checked baggage as long as all sharp objects are securely wrapped to prevent Screening Officers and baggage handlers from injury.

Hunting equipment, including knives, hunting rifles and bows and arrows for sporting use, is not permitted in carry-on baggage under any circumstances, but may be transported in checked baggage as long as all sharp objects are securely wrapped to prevent Screening Officers and baggage handlers from injury and guns are unloaded and securely locked and have been declared at the air carrier check-in counter.

All sporting goods equipment is allowed in checked baggage. However any equipment containing flammable chemicals are not allowed in checked baggage. Inflammable gases such as CO2 are as long as they are in two small cylinders

For flights wholly within the United States and between the United States and Canada The maximum amount of baggage each ticketed passenger is allowed free of charge is:

- 2 pieces checked and one carry-on
- Two checked bags at 62 in/157 cm each
- The maximum weight per checked bag is 50 lbs/23 kgs

For flights to international locations:

- Checked 2 62 in/157 cm each 50 lbs/23 kgs
- \$25 USD charge each for bags weighing 51-70 lbs.
- Baggage checked to London
 - O Passengers connecting between London Gatwick and London Heathrow are required to claim their checked baggage upon arrival in London, clear Customs with checked and hand baggage, and proceed directly to the connecting airport.
- Baggage checked to/through/from Europe and Asia
 - o In conjunction with the British Airport Authority mandate, no piece of baggage checked to/through/from any destination in Europe or Asia may weigh more than 70 lbs/32 kgs. Additionally, any piece of baggage weighing over 50 lbs/23 kgs is subject to a \$25 USD overweight baggage fee.

This policy only applies to passengers traveling on American to/through/from any destination in Europe or Asia. If you have baggage weighing over this limit, please repack or redistribute the weight into other baggage.

Size and Number of Pieces

- FAA security measures limit customers on all AA flights to one carry-on bag plus one personal item.
- All carry-on pieces, including laptops, must fit either underneath the seat in front of you or in an overhead bin.
- The one carry-on bag must fit in an overhead compartment or under the seat. It should not exceed 45 linear inches (length + width + height) or weigh more than 40 lbs/18 kgs.
- Carry-on items which appear too large or irregularly shaped to fit under a seat, in an
 overhead compartment, or in a closet will not be accepted as carry-on baggage and will
 need to be checked.

- At times, additional limits may be placed on carry-on baggage based on the main cabin stowage capacity of specific aircraft.
- These limits may be imposed after the boarding process has begun.
- Some carry-on baggage may be stowed in a cargo compartment on selected American Eagle aircraft.
- At some airports, carry-on baggage may be more restricted. All other luggage must be checked at curbside or at the ticket counter.
- Passengers exceeding the carry-on limit will not be allowed through the security checkpoint.
- All portable electronic devices, including laptops, must remain off during taxi, takeoff, approach and landing until we arrive at the gate and the seat belt sign is turned off.

Liquid Allowance for Carry-on Baggage

Customers traveling from the U.S. and Canada may take with them in their cabin bag limited quantities of liquids, gels, and aerosols, including travel-size toiletries such as shampoo, suntan lotion, creams, toothpaste, hair gel and hair spray.

Liquids must be carried in individual containers no larger than 3.4 ounces/100 ml.

All liquid containers must be carried in a separate clear plastic, zip-top bag (see example at right) that does not exceed 8 inches x 8 inches (20 cm x 20 cm) or is quart size. Items must fit in the bag comfortably and the bag must be completely closed.

Customers carrying liquids in their cabin bags may be subject to secondary searches before boarding.

- Customers traveling to the United Kingdom and whose journeys terminate at the first point of arrival in the U.K. may take one bag whose total dimensions (length +width + height) may not exceed 45 inches/ 114 cm, with each dimension no larger 22 in/56cm long, 18 in/45cm wide, and 10 in/25cm height. Customers may also bring one laptop sized bag, briefcase or equivalent.
- Customers transferring onto a flight through the UK (domestic and international) must comply with UK Department for Transport restrictions, which are ONE cabin bag, whose total dimensions (length +width + height) may not exceed 45 inches/ 114 cm, with each dimension no larger 22 in/56cm long, 18 in/45cm wide, and 10 in/25cm height.
- Liquid Duty Free items purchased in the United States or onboard non-European Union (EU)** airlines that exceed 3.4 oz./100 ml and are not in a quart-size plastic bag may be confiscated at the security checkpoint when connecting in Norway, Iceland, Switzerland or any EU country. All non-liquid/gel duty free items will be allowed when connecting.

The information shown below pertains to travel within the United States only (unless stated otherwise). For information on the transportation of firearms and ammunition to international destinations, please contact Reservations.

General Information

- Firearms and ammunition are accepted as checked baggage only.
- Firearms will only be accepted if unloaded and in a locked, hard-sided container only (for example - rifle case).
- Ammunition must be packed in its original packaging. Loose ammunition or clips will not be accepted.
- Firearms may not be checked curbside.
- No one under 18 years of age may check a firearm.
- Pellet and BB guns are not considered firearms, and therefore, do not require any special handling or documentation.

Allowance

- Maximum per case is 3 rifles/shotguns or 5 pistols/revolvers, 5 lbs. ammunition, shooting mat, noise suppressors, and tools. There is no limit on the amount of cases allowed.
- Ammunition is limited to 11 lbs. per passenger. Excess baggage charges may apply to each gun case if it is in excess of the free baggage allowance and/or oversize/overweight.
- Ammunition and gunpowder: Only small arms ammunition for sporting purposes is allowed as part of checked baggage, amount may not exceed 11 lbs./5 kg

Rods and reels contained in a case and one bag with fishing tackle, landing net, and fishing boots. Two pieces - Fishing rod case and fishing equipment bag are free in place of one 62 inch bag Fishing rod case 50 lbs. and 115 inches Equipment bag 50 lbs. and 62 inches

For purposes of excess baggage, two pieces count as 1 item

- You're allowed up to two pieces of checked baggage. Each bag can be a maximum of 62 linear inches (length + width + height) and may weigh up to 50 pounds. Excess baggage charges apply to additional pieces, overweight pieces between 51 and 100 pounds and oversized pieces of luggage.
- No single piece of checked baggage may weigh more than 100 pounds. Any piece in excess of 100 pounds must be forwarded via air cargo or alternative means arranged by the customer.

• You're allowed one carry-on bag, which can measure up to 10" H x 17" W x 24" L (25 x 43 x 61 cm), plus one personal item, such as a purse, briefcase or laptop computer. At least one of the items should be stowed under the seat in front of you.

- Shooting Equipment
 - a. One rifle case with rifles, scopes, one shooting mat, noise suppressors and small tools, or
 - b. One shotgun case with shotguns, or
 - c. One pistol case with pistols, noise suppressors, one pistol telescope and small pistol tools
- There is no limit to the number of items per case as long as they do not exceed 50 lbs., 62 linear inches.
- Ammunition—up to 50 lbs.(domestic) and 11 lbs. (international where permitted) may
 be checked, if securely packed in the original manufacturer's package or in a container
 designed for ammunition and of sufficient strength to protect it from accidental crushing
 or discharge (i.e. wood, fiber, plastic, or metal). The projectile must be no larger than
 11/16" in diameter, the size of a dime. Ammunition may be checked with or separately
 from the firearm

Firearms

The term "firearm" describes any weapon that will or is designed to or may be readily converted to expel a projectile by the action of an explosive, or the frame or receiver of any such weapon. This includes:

- Sporting rifles, shotguns, and handguns
- Handguns of authorized law enforcement officers while traveling on official duty
- Starter pistols, compressed air or BB guns, and flare pistols
- Antique firearms

Handguns must be unloaded and packed in a hard-sided locked case or in a hard-sided container inside a soft-sided case, one of which is locked with a key or lock combination only in the traveler's possession.

Rifles, shotguns, and other firearms must be unloaded and carried in a locked hard-sided container where only the customer retains the key. We also recommend that the bolt be removed and the slide locked open. All parts of the firearm must be packed in the same container as the firearm itself.

Alaska Airlines does not allow customers under age 18 to carry on or check a firearm.

International Transport

Canada - Handguns cannot be transported to or through Canada. Non-restricted hunting rifles or competition firearms do not require specialized documentation. Please call 800-731-4000 for additional information on firearms to or from Canada. A U.S. Customs declaration issued before departing the U.S. is required before bringing your firearms back to the United States. We cannot accept rifles, shotguns and other firearms between the United States and Canada without the required documentation.

Mexico - Handguns cannot be transported to or through Mexico. Before any firearm can be accepted for travel to Mexico, a consulate issued permit is required. Contact the Mexican consulate nearest you for additional information on firearms to or from Mexico. A U.S. Customs declaration issued before departing the U.S. is required before bringing your firearms back to the United States. We cannot accept rifles or shotguns and other firearms between the United States and Mexico without the required documentation.

Firearm Declaration

Identify all bags containing firearms when you check in. Firearms must be unloaded. You will be asked to read and sign a special tag for each bag/container holding a firearm(s). This serves as your declaration that each weapon is unloaded and both weapons and ammunition are properly packaged. It is your responsibility to obtain all the necessary permits for any firearm checked between the United States, Canada, and Mexico.

Prohibited Articles

Baggage may not contain hazardous materials or other prohibited articles, including:

- Flammable items such as fuel (sterno, butane, white gas, propane, lighter fluid) for stoves, lanterns, motors, etc.
- Pepper spray or bear spray/repellant

- "Strike anywhere" matches
- Propane tanks—because they cannot be completely purged
- Over 50 lbs. of ammunition
- Wet ice
- Over 5 lbs. of dry ice
- Styrofoam containers are never permitted as checked baggage, but may be carried onboard if small enough to fit under your seat

Fishing Equipment

- The following items may be checked free as a third bag: Two rods, two reels, and one tackle box encased in a proper hard case or Alaska Airlines box.
- Note: Fishing rods must be inside a single case. Cases may not be taped together.

Archery Equipment: 1 bow and 24 arrows

Antlers and horns

Only accepted as checked baggage if they are properly packaged in an enclosed container
and meet normal size and weight restrictions. Items that are oversized, overweight, or
improperly packaged must be shipped via Air Cargo. Please keep in mind this will
require additional time as the Air Cargo offices may not be near the departure terminal in
some cities.

Packaging Your Catch, Meat, or Trophy

It is your responsibility to properly package all perishable items and these items are checked at your own risk for spoilage. We recommend that you package raw meat and seafood so it is able to withstand a minimum of 48 hours in transit without refrigeration.

Fish and raw game meat may be accepted as baggage only if packaged in a leak-proof container (not styrofoam). Gel ice is recommended, but up to 5 lbs. of dry ice is acceptable. Items containing dry ice must be declared at check-in and labeled on the package. Wet ice is not allowed. Freeze or chill meat and seafood thoroughly before packaging for optimal final destination temperature.

Firearms

Continental accepts one item of shooting equipment per customer in lieu of one piece of free baggage. One item of shooting equipment is defined as one hard-sided shooting equipment case containing up to five firearms, with or without scopes, 11 lbs (five Kgs.) of ammunition and articles used in the firearm sport.

Firearms will be accepted only from a customer who is 18 years of age or older. International firearm regulations vary by destination and transiting country. Contact appropriate consulates or embassies to obtain specific entry requirements applicable to destination(s).

Firearms are not accepted to/from Israel.

Firearms are not accepted to/from Denmark

For travel to/from the United Kingdom, pistols, rifles and shotguns must be packed in a hard side rifle case.

Customers traveling to/through Amsterdam, Netherlands (AMS) with checked firearms/ammunition must obtain permission from the Netherlands Consulate/Embassy in their country of origin prior to departure. Weapons are subject to confiscation in Amsterdam unless the owner can show all required permits. Customers traveling on military orders with checked firearms may do so without prior consent from Dutch Customs. Checked military ammunition is forbidden. For your convenience, the application for permission is available for download in Adobe PDF format.

Curbside check-in of a firearm is not permitted.

The firearm must be packaged in a hard-sided container capable of being locked. The container must be locked and the key or combination must remain in the customer's possession. If a hard-sided container is needed, see the <u>container section</u> of this site. Handguns must be packed in hard-side lockable luggage. Baggage containing handguns must be locked at the time of acceptance by Continental Airlines and the key or combination retained in the passenger's custody.

The firearm will be transported in a section of the aircraft that is inaccessible to the customer. Proof of registration is not required.

Firearms carried in addition to the free baggage allowance will be assessed at the current excess baggage charge.

Ammunition:

No more than 11 pounds of ammunition may be carried. The ammunition may be packed in the same container as the firearm or in a separate container. Ammunition must be packed in the manufacturer's original package or securely packed in fiber, wood or metal containers. The ammunition inside the container must be protected against shock and secured against movement. The ammunition may be packed in the same container as the firearm or in a separate container.

Continental is not liable for damage to firearms that are not contained in hard-sided cases. **Note:** Customer must sign a Firearm Declaration Tag.

Continental accepts one item of fishing equipment per customer in lieu of one piece of free baggage. An item of fishing equipment consists of the following:

2 rods, 1 reel,1 landing net,1 pair of fishing boots, 1 tackle box.

- All items must be properly encased in a suitable container not to exceed 8" x 8" x 84".
- Fishing equipment over 80 inches in length will not be accepted as checked baggage on any itinerary involving a Continental Express* or Continental Connection flight.
- Fishing equipment carried in addition to the free baggage allowance will be assessed at the current excess baggage charge for a single piece, whether or not it is presented as a single piece.

Continental is not liable for damage to Fishing equipment.

Excess Valuation may not be purchased for Fishing equipment.

Archery Equipment

Continental accepts one item of archery equipment per customer in lieu of one piece of free baggage. All items must be properly encased in a suitable container.

An item of archery equipment consists of:

1 bow case containing bows

1 quiver with arrows

Maintenance Kit of sufficient strength to protect items from accidental damage.

Archery equipment carried in addition to the free baggage allowance will be assessed at current excess baggage charge.

Continental is not liable for damage to archery equipment that is not contained in a hard-sided case.

Antlers

Continental shall not be liable for damage to antlers. Antlers are subject to a \$95.00 service charge per item. One service charge applies when smaller antlers are nestled inside larger antlers and strapped together. This charge is in addition to any excess baggage charges that may apply. Continental Airlines will accept antlers retained as hunting trophies, for travel to/from the U.S. and Canada, provided the following conditions are met:

Aircraft size and load conditions permit

Antlers must be as free of residue as possible

Skull must be wrapped and tips protected

Antler linear dimensions (L+W+H) must not exceed 120 inches.

Excess Valuation may not be purchased for antlers.

Seafood

Continental Airlines will accept seafood as checked baggage if the following condition is met: Seafood will be accepted only if it is wrapped in a sealed protective material and packed in a leak-proof container.

Seafood will not be accepted if packed in wet ice or if packed in a Styrofoam container. Seafood carried in addition to the free baggage allowance will be assessed at the current excess baggage charge. In addition, seafood is subject to overweight and oversize charges. Continental shall not liable for seafood. Excess Valuation may not be purchased for seafood.

Checked Baggage

You can check **two bags** per passenger free of charge.

Each bag must:

- Weigh 50 pounds (22.5 kg) or less.
- Not exceed 62 inches when you total length plus width plus height.

If you have a bag that exceeds these allowances, see **Excess Baggage**.

Exceptions:

- Passengers traveling to or from Key West, Florida are limited to only **one** checked bag.
- The free weight allowance is 70 pounds (32 kg) for tickets purchased in Brazil.

With the exception of original factory-sealed boxes that will be accepted on a standby basis, we do not accept boxes as checked baggage to Central or South America (except Brazil, Mexico, and Chile) at any time of the year.

Carry-on Baggage

Advisory: New security measures have been implemented which necessitate an earlier arrival. See **Security Checkpoints** for details.

You can carry on **one bag** plus **one personal item** per passenger as long as it:

- Weighs less than 40 pounds (18 kg).
- Does not exceed 45 inches when you total length plus width plus height.
- Fits easily into our SizeWise® unit (approximately 22"x14"x9").
- Fits in an overhead bin or underneath the seat in front of you.

Here are some examples of personal items:

- Male or female purse
- Briefcase
- Laptop computer (All laptop/computers must be carried aboard and cannot be checked. For information about Delta's battery-saving system for laptops, visit **Connectivity**)
- Camera case
- Diaper bag
- Items of a similar or smaller size to those listed above, such as **Portable Electronic**Devices

These additional items are okay to carry on and don't count towards your allowance:

- Food items for immediate consumption
- Assistive devices such as wheelchairs or crutches, provided passenger is dependent on them
- One box or bag of duty free merchandise
- A coat or jacket
- An umbrella
- One item of reading material

There may be more limits to carry-on baggage based on available space and additional restrictions on certain flights.

Liquids and Containers

Taking a few minutes to prepare may help to prevent some real hassles at security or even the frustration of having some personal property confiscated. Most countries now prohibit or strictly limit the size of containers with liquids, gels, aerosols, and pastes that you can take in your carry-on luggage. Empty containers that could contain liquids are usually prohibited as well.

Examples of liquids and gels included in these security measures are:

Beverages, Creams, Hair gel, Hair spray, Shampoo, Suntan lotion, Toothpaste and other items of similar consistency

You'll go smoothly through the security checkpoints in most countries if you follow these guidelines for your carry-on baggage.

- Do not pack or carry any empty containers.
- Limit all liquids, gels, aerosols, and pastes to a maximum container size of 3.4 oz/100ml.
- Place all such items in a quart-size, clear plastic, zip-top bag.
- Remove your quart-size bag from your carry-on and place in the provided bin as you approach the checkpoint.

In some airports it is possible to purchase these type of items and take them on board the aircraft once you've cleared security. However, if your continuing travel takes you through additional checkpoints where they're prohibited, they could be confiscated.

Special provisions are usually made for necessary items such as medications and baby formula. For specific guidelines, visit the additional resources below for links to the appropriate government agency.

One item of shooting equipment is accepted as your free checked baggage allowance. When checking a firearm, you must:

- Declare to the Delta representative that you are checking a firearm (If a Security Checkpoint is prior to the Delta ticket counter, you must declare the existence of a firearm to security personnel.)
- Present firearm(s) **unloaded** and sign a "Firearms Unloaded" declaration
- Lock the firearm(s) in a hard-sided, crush-proof container and retain the key or combination
- Maintain entry permits in your possession for the country or countries of destination or transit
- Ensure small arms ammunition is packed in the manufacturer's original package or securely packed in fiber, wood or metal boxes

Firearms transported to the United Kingdom as checked baggage require a permit from the United Kingdom. The passenger must contact the United Kingdom for more information regarding this permit.

Ammunition in excess of 11 lbs. per passenger or that contains incendiary projectiles is prohibited.

Rifles

One rifle case containing:

- two or fewer rifles (with or without scopes)
- one shooting mat
- one small pistol tool kit
- noise suppressers
- 11 lbs. (approx. 5kgs) of ammunition

An excess baggage charge will apply to cases containing more than two rifles.

Shotguns

- two shotguns
- two shotgun cases
- 11 lbs. (approx. 5kgs) of ammunition

An excess baggage charge will apply to cases containing more than two shotguns.

Pistols

One pistol case containing:

- five pistols
- pistol telescopes
- noise suppressers
- a small pistol tool case
- 11 lbs. (approx. 5kgs) of ammunition

An excess baggage charge will apply to cases containing more than five pistols.

Archery equipment: accepted as part of your free baggage allowance. The items must be encased in a container strong enough to protect the items from damage.

Antlers:

You *can* bring that trophy home. We will accept animal racks/antlers, although they are not included as part of the free baggage allowance. A fee of \$100 per animal rack/antler will apply. The following restrictions apply:

- Antlers will be accepted on Delta Connection flights only if space is available.
- Antlers must be free of residue and the skull must be wrapped and the tips protected.
- Linear dimensions must not exceed 120 inches (305cms). Any animal rack/antler that exceeds 120 linear inches cannot be accepted.

Because space can be limited, we can't always get the antlers on the same plane with you. If we don't, we'll hold them at your destination for you to pick up when you can or you can have them delivered for a charge.

Checked Luggage Weight and Measurement

Luggage is measured by adding length, width and height to determine the total number of linear inches/centimeters.

Northwest will accept luggage up to a maximum of 50 pounds (23 kg) and a total linear dimension of 62 inches (158 cm) per piece at no charge.

Additional charges may apply for luggage weighing more than 50 pounds (23 kg) or with a total linear dimension of more than 62 inches (158 cm) per piece.

For domestic and trans-Atlantic travel, the maximum weight accepted for any piece of checked luggage, including special luggage items, is 70 pounds. For trans-Pacific travel, the maximum weight accepted for any piece of checked luggage is 100 pounds. Items that exceed these limits can be shipped as cargo.

Note: If you are flying on a codeshare partner, please check with the operating carrier for maximum acceptance rules as they may vary.

* Bags checked to or through Europe or with a connection to Continental Airlines cannot exceed 70 pounds (32 kg).

Free Checked Luggage Allowance

- Checked luggage within the free 2 bag allowance that weigh more than 50 pounds and up to 70 pounds will be assessed a \$50.00 heavy bag fee.
- Checked luggage within the free 2 bag allowance whose linear dimensions exceed 62 inches will be assessed 2 excess baggage charges.
 See rate table.
- (Applicable to transpacific travel between North America and Asia)
 Checked luggage within the free 2 bag allowance whose weight exceeds
 70 pounds will be assessed 3 excess baggage charges.
 See rate table.

World Business Class: Each ticketed passenger is allowed three (3) pieces of checked luggage. One (1) piece of carry-on luggage is allowed per passenger.

- 0. First two (2) pieces: 70 pounds (32 kg) with linear dimensions not to exceed 62 inches (158 cm).
 - Checked luggage within the first 2 bag allowance whose linear dimensions exceed 62 inches will be assessed 2 excess baggage charges. See rate table.
 - (Applicable to transpacific travel between North America and Asia) Checked luggage within the 2 free bag allowance whose weight exceeds 70 pounds will be assessed 3 excess baggage charges.

See rate table.

1. Third piece: 40 pounds (18 kg) with linear dimensions not to exceed 45 inches (115 cm). If third piece exceeds either weight or linear dimensions above, it will be subject to excess bag charges based on actual weight and size.

Items that weigh more than 70 pounds (32 kg) for domestic or trans-Atlantic travel or more than 100* pounds (45 kg) for trans-Pacific travel, must be shipped as cargo using a known shipper/freight forwarder, or repacked to comply with luggage requirements.

International Travel - with origin and destination outside United States / Canada For travel with an origin and destination outside the U.S./Canada (i.e. within Asia or within Europe), the weight concept applies. The weight concept allows a maximum weight for luggage, per person, that can be checked free of charge. The free weight applies to the total weight of all bags checked by an individual.

For travel wholly within or between Asia, Europe, the Middle East and Africa, the maximum checked luggage weight limitation is:

Coach Class: 44 pounds (20 kg)

World Business Class: 66 pounds (30 kg

Firearms, Handguns, and Ammunition

- Passengers should check with Northwest for current policies, requirements, and restrictions on traveling with firearms and related items.
- Northwest Airlines does not accept guns or firearms of any kind in carry-on luggage.
- Passengers under 18 years of age traveling alone will not be allowed to check any type of gun.
- Northwest accepts handguns, BB guns, rifles, and shotguns as checked luggage, with certain limitations and requirements.
- Northwest accepts one of the following in lieu of one piece of luggage included in the free luggage allowance:
 - One (1) rifle case containing no more than four (4) rifles/shotguns, one (1) shooting mat, one (1) noise suppressor and tools.
 - Two (2) rifle cases containing a combined maximum total of four (4) rifles/shotguns is considered as one (1) item.
 - One (1) pistol case containing no more than five (5) handguns, one (1) scope, one (1) noise suppressor and tools.

When checked piece containing guns is in excess of free weight allowance, appropriate excess charges apply.

- Checked piece may be larger than standard 62 inch size restriction.
- In addition to one (1) of the above items, Northwest accepts small arms ammunition up to a maximum of 11 pounds (5 kg). Guns and ammunition may be in the same piece of luggage. However, ammunition must be within its own packaging.

For trans-Atlantic and trans-Pacific travel, firearms may be included in the free luggage allowance as described above. However, for international travel you must obtain and comply with regulations governing the transportation of firearms for *ALL* countries you are traveling to, including those where only flight connections occur.

Northwest accepts firearms, handguns, and ammunition under the following conditions:

- All firearms must be locked in a suitable crush-proof / hard-sided container manufactured specifically for firearms or hard-sided suitcase. Hard-shell gun cases can be purchased at domestic airports.
- Ammunition must be in the manufacturer's original packaging or a container specifically designed for ammunition. Ammunition with explosive or incendiary projectiles will not be accepted.
- Due to TSA regulations, gun cases must be properly locked. Often gun cases require further TSA inspection.
- To avoid the breaking of passenger's gun case locks, NWA recommends the use of TSA approved locks. TSA approved locks (Searchalert) come with a tool that enables TSA screeners to open the lock without damaging it. Searchalert locks are available for sale at NWA stations in Calgary, Edmonton, Montreal, Toronto and Winnipeg.

Northwest does not accept liability for loss, damage, or delay of firearms, handguns, and ammunition. Excess valuation insurance <u>may not</u> be purchased for transport of firearms, handguns, and ammunition.

Northwest does not accept liability for loss, damage, or delay of antlers. Excess valuation insurance may not be purchased for transport of antlers.

Archery Equipment

Northwest accepts one set of archery equipment (bow, quiver, arrows and case) in lieu of one piece of luggage included in the free luggage allowance for travel within/between US/PR/VI/CA only. Northwest only accepts archery equipment as checked luggage. For trans-Atlantic or trans-Pacific travel archery equipment cannot be included in the free luggage allowance and will be assessed normal excess bag charges based on size and weight.

The archery equipment must be encased in a container of sufficient strength to protect the items from damage.

Northwest does not accept liability for loss, damage, or delay of archery equipment. Excess valuation insurance may not be purchased for transport of archery equipment.

Fishing Equipment

Northwest accepts one set of fishing equipment (two (2) rods with reels, creel, net, pair of boots and tackle box) in lieu of one (1) piece of luggage included in the free luggage allowance. Fishing

- If these time limits are not met, United will be excluded from liability.

For travel worldwide on United, you may carry on one bag and one personal item such as a purse, briefcase, or laptop computer.

In the European Union, items must fit in one clear, re-sealable liter-sized plastic bag, in containers of 100ml/3.3oz or less. (Please note: The TSA's exact measurements are stated above. But for ease of memory please follow the 3-1-1 rule.)

Plastic bags must be completely sealed and will be x-rayed at the security checkpoint separately. The following items are allowed, but must be presented to officials at security checkpoints if they are not contained in clear plastic bags or are of greater volume than 3.4oz/100ml in the U.S. or 100ml/3.3oz in the EU:

- Baby formula/milk, including breast milk, and baby food in containers if a baby or small child is traveling.
- Medications (liquid, gel or aerosol)
- Liquids, juices or gels for diabetic passengers who indicate a need for such items to address their medical condition. (A letter from your physician is not necessary).

Passengers are permitted to take liquids, gels, and/or aerosols purchased in the boarding area onboard the aircraft. This includes all duty free items.

Though there is some flexibility regarding duty free items within the EU, restrictions still apply elsewhere. Duty free liquids, gels, and/or aerosols that exceed the TSA limit will not be permitted on most connection flights worldwide.

On flights from the U.K. or Belgium, the limitation of one carry-on item per person is strictly enforced.

Firearms

Federal regulations require that firearms in checked baggage or in their own shipping case be unloaded and declared. Firearms are not allowed in carry-on bags. Firearms in checked baggage must be packed in a locked hard-sided bag or gun case. A maximum of 11 lbs. of small arms ammunition is allowed in checked luggage in the original manufacturer's box or securely packed in a fiber, wood, or metal box to prevent movement of cartridges.

US Airways will allow passengers to transport firearms in accordance with Federal Law. The following conditions must be met:

Items of shooting equipment will be accepted as **checked baggage** only.

A passenger who presents baggage containing a firearm must declare and demonstrate that the weapon is unloaded.

Firearms **must** be packed in a manufacturer's hard—sided container specifically designed for the firearm, a locked hard—sided gun case, or a locked hard—sided piece of luggage. Handguns packed in a hard—sided gun case may be packed inside a soft—sided piece of luggage. A Conditional Acceptance Tag must be used in this case.

Baggage containing firearms must be locked at all times and the key or lock combination retained by the passenger.

A Firearm Unloaded Declaration form must be signed and placed inside the bag or gun case

Ammunition must be packed in the original manufacturing package or metal/wood box, with a maximum of 11 pounds per passenger.

There is no limit to the number of items contained in rifle, shotgun or pistol case, up to 50 lbs., 62 inches in maximum.

Limited quantities of liquids, gels or pastes must be held in individual containers not exceeding 100ml (approximately 3.5 fl. oz).

This may include:

 Shampoo, Creams, Hair gel, hair spay, Suntan lotion, Toothpaste, Liquid or aerosol, deodorants, Perfumes, Cosmetics such as mascara and lip gloss, Water and other, drinks, soups and syrups and other items of similar consistency

The containers must be carried in a separate clear plastic, zip-top or re-sealable bag that does not exceed 20 cm \times 20cm (8 inches \times 8 inches) or equivalent to one litre capacity.

You must contact British Airways at your departure airport 24 hrs in advance of your flight.

- The gun must be unloaded, dismantled and packed securely in a storage case to go in the aircraft hold (any locks should be fastened, however please ensure that you have the keys with you for any security inspections).
- Passengers must carry any shotgun/firearm certificates that they have.
- Sporting guns are defined as such guns as air rifles, safari rifles, hunting rifles, etc.
- Any ammunition to be carried must be for sporting purposes only, and the maximum gross weight must not exceed 5kgs per passenger.
- All ammunition must be securely boxed and preferably stored inside a suitcase.
- Any suitcases/carry cases/boxes containing ammunition must not bear an 'explosives' label.
- The gun must be unloaded.
- If possible the gun should be dismantled.
- Guns must be packed securely inside a suitcase, or in a separate carrier.
- Ammunition must be for sporting purposes.
- The weight of the ammunition must not exceed 5kg (11lbs) per passenger sharing the weight allowance between passengers is not allowed.
- Ammunition must be securely boxed and preferably packed inside a suitcase.
- Baggage containing ammunition must not bear 'explosives' labels.
- There is no limit to the number of guns per passenger.

• The carriage of guns must be notified to British Airways at least 24 hours before travel.

(100 ml) capacity or less per container. The contents of the plastic bag must fit comfortably and the plastic bag must be completely closed/sealed and subjected to x-ray inspection separate from the passenger's carry-on bag.

You may have the items listed below, but you must declare them to TSA at the screening checkpoint if they are not contained in a clear transparent re sealable 1 quart (1 liter) size plastic bag and/or are over 3 oz. (100 ml).

Checked Baggage:

Allowance by weight

It corresponds to the weight that you can transport free-of-charge by destination and class of travel

The dimensions of your baggage must not exceed **158 cm** (height + length + width).

If you wish to transport baggage items that are heavier than the indicated weight, you must **pay a supplement** when you check in.

Each kilo of excess baggage will be charged at the following rates:

- within zone 1: €3/kg
- between zones 1 and 2 and zone 2: €12/kg
- between zones 1 and 2 and zone 3: €20/kg
- between zones 1 and 2 and zone 4: €30/kg
- within zone 3: €20/kg
- within zone 4: €30/kg

If you are a Flying Blue member, you can take advantage of an additional allowance as shown on your ticket:

- + 5 kg if you are a Flying Blue Silver member,
- +10 kg if you are a Flying Blue Gold member,
- +20 kg if you are a Flying Blue Platinum member,

Carry-on Baggage:

Please note that different airplanes have different allowances for your hand baggage!

Transportation rules

- Cabin baggage or hand baggage refers to any other type of baggage that is not checked into the hold.
- You may transport:
 - In the Tempo cabin:

 - valuable items: keys, mobile phone (switched off), passport and ID, important documents, money, valuables, jewelry, etc.,
 - fragile objects: camera, IT hardware (switched off), paintings, crockery, etc.
- Liquids are subject to specific measures: see paragraph below.

How to prepare your cabin baggage?

- 1 Obtain a transparent plastic bag that can be resealed (for example, a freezer bag) with a capacity of **one liter (30 floz)** maximum (size around $20 \text{cm} \times 20 \text{cm} / 7,5$ inch $\times 8$ inch). **Only one bag** of this type is authorized per passenger.
- 2 Place in this bag all liquids and similar products of which each container must not exceed 100 ml (3 floz) maximum.
- 3 All other containers of a larger capacity must be properly protected and placed in your checked baggage.

Important!: At the time of making the reservation, you must have on hand the CBP 4457 permit. You must also know the weight and dimensions of your rifle before you make your reservation because this information must be given at that time. The form is only acting as a proof of ownership.

Hunting rifles designed for sporting use

Air rifles, hunting and safari guns are all regulated weapons. In order to transport them, you must possess:

- a gun permit, which will be demanded at check-in,
- the necessary documents for transportation of weapons and ammunition:
 - import/export licenses,
 - permits awarded by local and national authorities.

This material is included in the baggage allowance.

Accepted ammunition

The following are accepted:

- ammunition for all hunting weapons,
- Ammunition for calibers less than or equal to 19.1 mm.

Packaging

- This ammunition must be packaged in fiberboard, wooden or metal boxes, up to a maximum of 5 kg gross per passenger (gross weight = weight of cartridges + weight of box used to package them).
- Cartridges must be correctly fitted inside their packaging. In order to avoid the cartridges slipping, any free space must be filled with stuffing material.
- The transport of loose cartridges that are not correctly packaged is prohibited.

For your information

- Sporting and hunting guns are not considered as dangerous goods but must be kept separate from their ammunition.
- At check-in, you must declare that your weapons are not loaded and that the cartridges are packed.

• Can my firearm travel with me?

Yes, however all firearms must be declared at time of check in and may not be checked in as checked baggage. The firearm must be handled via the designated firearm handling process.

Hand Held Firearms

A R100 handling fee is raised for the carriage of hand held firearms. Payment will only be

accepted in the form of credit cards or cash at the firearm desk or allocated firearms acceptance area. These firearms will be processed at the firearm desk for safe carriage in the hold of the aircraft.

Rifles (in gun case / rifle bags)

Rifles must be processed via the firearm desk for safe carriage and may form part of your free baggage allowance. Thereafter the excess baggage allowance will be raised as applicable

Ammunition

A maximum of 5kg securely boxed ammunition per passenger will be permitted for carriage in the hold of the aircraft.

Import of Firearms

Strict legislation on the carriage / importation of hand held firearms exist in almost all countries and heavy fines could be imposed on the passenger and the carrier should such items be landed without the necessary documentation (e.g. import permits / licence etc.) It is the **RESPONSIBILITY OF THE PASSENGER** to consult with the local consulate of the country to which he / she will be travelling (including transit / stopovers where applicable) to establish and comply with all entry requirements of the countries concerned.

RSA citizens and residents require RSA firearm licence. Visitors require a Temporary Import Permit. Temporary import permit will only be issued for foreign hunters and participants in an organised sport shooting event. Temporary Import permit can be obtained on arrival or at least four weeks before arrival in RSA from "The Registrar, Private bag X 811, Pretoria, 0001, Republic of South Africa. The application form (SAPS 520) for the Temporary Import Permit and Firearms Control Act 60 of 2000 can be obtained on arrival.

Requirements:

- * Passport
- * Return airline ticket
- * Firearm licence (or proof of ownership) from country of residence.
- * Invitation letter from Outfitter or Sport shooting event organiser (on official letterhead)
- * Letter from owner of firearms stating the reasons why the firearms are needed in South Africa
- * Address where person will stay in SA
- * Export permit from country of residence.

Restrictions:

- * No automatic, semi-automatic firearms or military weapons are allowed
- * No firearms for self-defence allowed
- * Only one firearm per calibre allowed
- * Only 200 rounds of ammunition allowed per firearm
- * No handguns may be imported to South Africa without the necessary prior obtained permits
- * Person must be 21 years and older to enable them to import a firearm to South Africa

Arrival in South Africa

All firearms entering the country must be cleared via the SAPS Firearms Office. Kindly complete the necessary forms, after clearing this process, a temporary Import Permit is issued, and you will be able to clear customs.

Angling Equipment

One tackle box, haversack or anglers' basket plus one rod, bag or box is included in the free baggage allowance. In case of excess, following rates apply:

WC: if in excess up to 15 kg (33lb), the charge shall correspond to the applicable rate of 4kg (9lb) of excess baggage; for any weight in excess of 15 kg (33lb) the normal excess baggage charges apply.

Baggage Allowance

Luggage Franchise includes all that the passenger is allowed to carry without charge. It includes what is dispatched as registered luggage in holds and what the passenger takes on board to the cabin, as handbags.

There are two Luggage Franchise systems:

Weight System

Allows the transport of a specific amount of kilos, out of which a charge should be paid for excess baggage. Regarding the luggage to be dispatched, the weight limits that can be transported without charge are the following:

Except:

- flights between South America (except Brazil) and Europe via Buenos Aires 40 kilograms
- flights between Buenos Aires and Mexico 40 kilograms
- flights between Lima and Mexico 40 kilograms
- flights from Buenos Aires to Peking 40 kilograms

By Piece System:

Allows the transport of a fixed amount of pieces, on the basis of a pre-fixed volume and weight, out of which a charge should be paid for excess luggage.

This system, used in some countries as the USA, Australia and New Zealand, permits each passenger to carry, without charge:

Economic Class

Quantity 2 (two) checked suitcases (pieces)

Weight up to 32 kilograms weight each

Dimension the sum of the three dimensions of each piece must not exceed 158 cm

Between both no must exceed 273 cm

Clase Club Cóndor

- Quantity \rightarrow 2 (two) checked suitcases (pieces)
- Weight → up to 32 kilograms weight each
- Dimension \rightarrow the sum of the three dimensions of each piece must not exceed 158 cm

Shooting / Hunting Equipment (*) (A case with 2 rifles + 5 kg of ammo + a target for shooting + Noise suppressors + small tools or two shotguns and its cases or a case with 5 pistols + 5 kg of ammo + noise suppressors + small tools)

Domestic: One equipment **is considered part of the free franchise** luggage. If surpassing the franchise or additional equipments: normal charges for excess baggage.

Regional/International: One equipment is considered part of the free franchise luggage. If surpassing the franchise or additional equipments: normal charges for excess baggage.

International: One equipment is considered part of the free franchise luggage. If surpassing the franchise or additional equipments: normal charges for excess baggage equivalent to a basic rate.

Transport of Weapons

The following objects are considered weapons:

Firearms of all types and calibers, Collection firearms (working or not), Imitation firearms or war-like toys, Ammunitions, Blunt elements, Sharp, cutting and/or piercing elements, Tools, Any articles suspected of causing wounds

The security regulations in force prohibit the transport of any of these objects in the cabin, and therefore they should be dispatched in cargo compartments as registered luggage.

The weapons must be unloaded, disassembled and packed according to the required security regulations.

Ammunitions and cartridges must be transported in their original packaging or in a box, separated by cells.

Under no circumstances will the transport of live or incendiary ammunition, nor any war weapons be accepted.

Passengers who belong to Security Organizations traveling with their weapons (revolvers, pistols) should use an arms sack or dispatch them as freight.

Documentation

Exiting

Passengers who travel abroad with a weapon must be of legal age and accredit legitimate
use of same through the pertinent documentation issued by the National Weapons
Register (R.E.N.A.R).

Entering

• Passengers entering the country with a weapon must be of legal age and have the proper authorization from his country of origin, stating: type, brand, model, caliber, serial number and ammunitions.

- Security attaché cases that incorporate lithium batteries or pyrotechnical devices are totally prohibited.
- Incapacitating devices such as mace, stinging aerosols, etc. that contain irritant or incapacitating substances are also totally prohibited.
- Devices or equipment that contain mercury cannot be transported as luggage, with the exception of a barometer, transported by a member of an official weather bureau (only as hand baggage) and a small clinical thermometer for personal use in its protective case.

For security reasons it is forbidden to carry inside the luggage the following elements considered dangerous:

- Infectious substances and samples for medical diagnoses
- Flammable compressed gases, non-flammables and toxics: gas canisters, compressed air cylinders, aerosols or underwater air tanks.
- Corrosives (acids, alkalines): wet cell batteries.
- Explosives: weapons, munitions or pyrotechnical elements.
- Flammable liquids or solids: fuel for lighters, matches and articles that easily catch fire.
- Radioactive material.
- Oxidants and Irritants: bleaching substances, peroxide, chlorinated water, hydrogen peroxide.
- Toxic or Poisoning Agents: arsenic, cyanide, insecticides or herbicides.

If we do, these must be packed in accordance with all applicable national and international laws and regulations. Our approval may be withheld at our sole discretion. Fishing Equipment

A fishing kit consists of two rods, one reel, one landing net, one pair of boots and one tackle box. To be accepted for carriage, fishing rods must be protected in a PVC cylinder with screw ends, which can be obtained from a local fishing store, or in PVC plumbing or electrical tubing. Fishing rods must not be strapped to suitcases.

Baggage Allowance

15. Baggage

If the Airline accepts as baggage any items, not corresponding to the definition of "baggage", given in these Rules, transportation of such items will also be regulated by these Rules.

- 15.1. Items not acceptable to transportation as baggage
- 15.1.1. Passenger should not include to the baggage the following things:
 - Goods, items, liquid and other substances, able to create a considerable risk for health of Passengers, for safety of the flight or property of the Airline, or to other Passengers at the time of transportation, including explosives, compressed gas, flammable materials, oxidants, poisonous, harmful or irritative substances, radioactive materials, materials that

- cause corrosion, magnets, as well as any other items and substances, which are forbidden for transportation in passenger aircraft;
- Goods and items, transportation of which is forbidden by applicable laws of any country, from the territory of which, on the territory of which, or through the territory of which transportation will be fulfiled;
- Goods not suitable for transportation due to their nature, weight, dimensions, form or smell:
- Live animals and birds, except the cases, stipulated in point 15.18 hereof.
- 15.7. Special pieces of baggage, not covered by the norms of free baggage allowance
- 15.7.1. The norms of free baggage allowance shall not cover bulky and non-standard baggage, the dimensions or weight of which are considerably different from regular baggage being transported, namely:
 - Sports equipment (skiing and water-skiing equipment and skiing boards; golf equipment; wind-surfing and surfing equipment, diving equipment, fishing equipment, hockey sticks; vaulting poles and so on);
 - Weapons and ammunition, other than firearms of members of armed forces of the State Security Department (SSD) of Ukraine on official duty.
- 15.7.2. Transportation of special baggage, mentioned in point 15.7.1., must be agreed upon with the Airline, and paid according to the established fare regardless of the weight of other baggage, carried by the Passenger.

Firearms and Ammunition

- 15.1.2. Ammunition, firearms and cold steel, including antiquarian firearms and cold steel, cutting and piercing items shall be accepted to transportation pursuant to points 15.11. and 15.14.
- 15.11. Transportation of weapons and ammunition
- 15.11.1. It is prohibited to transport any weapon and ammunition by airlines company BC except:
 - Rifled army type firearms and its cartridges:
 - Produced of the special order firearms and its cartridges;
 - Emasculated, training, out-of-date shooting, sports, hunting rifled, combined and smooth-bore weapon and its cartridges;
 - Pneumatic weapon and its cartridges;
 - Domestic produced devices for shooting off of cartridges equipped with rubber or similar in characteristics missiles of non-lethal action and its cartridges;
 - Cold steel (arbalests, hangers, daggers, sabers, rapier, bayonet, clubs, hunting and Finnish knives, katanas, broadswords, yataghans, bayonet- knives);
 - Gas pistols and revolvers.
- 15.11.2. Cartridges for gas weapon, cartridges with bursting and incendiary charges will not be accepted for transportation by airlines company BC.
- 15.11.3. Permission for weapon and ammunition transportation is accepted only from natural persons airlines company passengers, if their right for its possession, import/export is confirmed by permission of authorized bodies.

Order of weapon and ammunition by legal entities is determined by Rules of air transportations of airlines company freights.

15.11.4. Weapon and ammunition allowed for transportation has to be transported only by direct (transit) flights of airlines company to airports/from airports, where there are VV representatives, in registered luggage in conformity with procedures, fixed by airlines company.

Fire-arms and ammunition of authorized persons, providing security and police functions, within their

coarse of duty will be transported by direct, transit and transfer flights of the Airlines company in conformity with clause 15.11.8. of these Rules.

- 15.11.5. It is prohibited to transport weapon and ammunition in unescorted luggage.
- 15.11.6. For the time of the flight weapon and ammunition is withdrawn from the Passenger and transported in BC baggage compartment. There is exception only for authorized personnel of law enforcing bodies, who are in coarse of duty.
- 15.11.7. It is strictly prohibited for passengers to bring any weapon and ammunition, even souvenir or other imitations and children toys to BC passenger saloon.
- 15.11.8. Transportation of weapon in BC passenger saloon is allowed only to authorized personnel of law enforcing bodies, who are in coarse of duty in cases envisaged by legislation in force and if they have all necessary documents.
- 15.11.9. Weapon is accepted for transportation only in discharged condition with separated ammunition.
- 15.11.10. Withdrawn cold steel, short-barreled fire-arms and ammunition has to be transported in special packages in equipped metal container in BC baggage compartment, the key to which will belong to BC crew within the flight and stoppage in transit airport.
- 15.11.11. Withdrawn non-separable weapon with length more than 80 cm has to be transported in BC baggage compartment in provided by owners cases, special containers, boxes, etc., equipped with safe bars.
- 15.11.12. It is strictly prohibited to transport withdrawn weapon in BC pilot cabin or passenger saloon and to return it to Passenger on BC board or on the platform.
- 15.11.13. Passenger may transport up to 5 kg of ammunition (gross weight) to the weapon allowed for transportation.
- 15.11.14. It is prohibited to combine norms for ammunition transportation for several Passengers.
- 15.11.15. Ammunition, transported by several Passengers, should not be combined into one or several luggage places.
- 15.11.16. Weapon and/or ammunition accepted for transportation will be returned to the Passenger at destination place by airport air security personnel in a special place and in presence of Airlines company representative.

TSA Unlock Checked Baggage Information

The TSA (Transportation Security Administration Of U.S.A.) has been started to screen all passenger's checked baggage at U.S. airports effective from January 01, 2003. Therefore would like to remind you something as below especially when you depart from USA.

- 1. TSA will have to open passenger's baggage as part of screening process, if the baggage is locked and TSA needs to check the baggage then locks may have to be broken. Therefore TSA suggests that to prevent the need to break baggage locks by keeping check-in baggage unlocked.
- 2. TSA is not liable for damage to the locks and also not accept baggage damage or pilferage claims. When passenger's belongings are missing from the Unlock Checked Baggage, please feel free to contact the TSA Consumer Response Center, TSA will assess any claims made to TSA on an individual basis. Piece system applies to baggage through-checked:

- 1. Between points in Area 3 (includes all of Asia and the Southwest Pacific) and points in USA / Canada / Mexico / Panama / Peru / Bolivia / Argentina / Brazil / Chile / Paraguay / Uruguay via North / Central Pacific, except for transportation originating from Mexico / Pakistan / Singapore / (Note: For transportation from Singapore to the USA piece system applies.)
- 2. And From Taiwan to points in Central America and the Caribbean area.

Checked baggage

First Class Two pieces of baggage of which the sum of the greatest outside linear dimensions of each does not exceed 62 inches (158cms), and the weight of each does not exceed 70lbs (32kgs).

Dynasty Class The same free baggage allowance as that for First Class shall apply.

Economy Class

Two pieces of baggage (measured together) of which the sum of the greatest outside linear dimensions does not exceed 107 inches (269cms), provided the sum of the outside linear dimensions of each bag does not exceed 62 inches (158cms), and that the weight of each does not exceed 70lbs (32kgs).

P.S.: If passenger has a direct connecting flight with North America Regional carriers, the free baggage allowance might be different from each carrier (baggage allowance in U.S region is 50lbs /22kgs), passenger should follow with the new carrier's baggage regulations accordingly.

- 1. First Class customers are allowed two pieces of cabin baggage, the sum of the first cabin baggage must not exceed 115cm (56x36x23cm). The second may be either asame size carry-on baggage or a garment carrier (Folded, a maximum depth of 20cm)and each baggage weighing not more than 7 kilos.
- 2. Business Class customers may be allowed two pieces of cabin baggage, however thesecond one must be a garment baggage, each baggage size and weight are all same as First Class. Please note that the 2nd piece of carry-on baggage under the standard size and weight may be accepted but subject to the aircraft stowage availability.
- 3. These dimensions include wheels, handles and side pockets, the weight of the cabin baggage is limited of up to 7 kilos.
- 4. In addition to cabin baggage, passenger also can carry the following personal effects such as: a purse, an overcoat, a laptop computer or small package of duty free items on board. Baby buggies and adult wheelchairs should be checked in as baggage.
- 5. All lighters are prohibited as carry-on items.

Firearms and ammunition for hunting and sporting purposes may be accepted as checked baggage in accordance with CAL's Regulations. Firearms must be unloaded with the safety catch on, and suitably packed. Carriage of ammunition is subject to ICAO and IATA Dangerous Goods Regulations.
- **9.1.4** Weapons such as antique firearms, swords, knives and similar items may be accepted as checked baggage, in accordance with Carrier's Regulations, but will not be permitted in the cabin.

- 2. Guns are to be dismantled.
- 3. They will only be carried in the baggage hold of the aircraft.
- 4. They must be packed separately from other baggage.
- 5. They must be available for inspection by security.
- 6. Ammunition on its own is limited to 5kg per passenger and must be packed in containers of wood, metal, or fireboard with the contents protected against any movement. It must be available for inspection.
- 7. They will be subject to a max baggage allowance of 30k including arms and ammunition.
- 8. All government and legal regulations must be complied with.
- 9. All documentation and licenses are the passengers responsibility.
- 10. Subject to an extra charge for the carriage of sports guns and ammunition. (see baggage information for carriage of sports equipment)

Restricted articles

- (A) Guns**, firearms & weapons, any object capable or appearing capable of discharging a project or causing injury including
- (B) Pointed edged weapons & sharp objects, pointed or bladed articles capable of causing injury including
- (C) Blunt instruments, any blunt instrument capable of causing injury including
- (D) Explosives and flammable substances, any explosive or highly combustible substances which poses a risk to the health of passengers and crew or the security/safety of the aircraft property including
- (E) Chemical and toxic substances, any chemical or toxic substance which poses a risk to the health of passengers and crew or the security/safety of aircraft or property including
- (F) liquids, unless in individual containers with a capacity not greater than 100 millilitres or equivalent and contained in one transparent re-sealable plastic bag of a capacity not exceeding 1 litre. The contents of the plastic bag shall fit comfortably and the bag shall be completely closed. Liquids include gels, pastes, lotions, liquid/solid mixtures and the contents of pressurised containers, e.g. toothpaste, hair gel, drinks, soups, syrups, perfume, shaving foam, aerosols and other items of similar consistency.

Specialty Items

At time of booking, Aer Lingus Reservation staff, or your travel agent, must be informed if you plan to travel with sports equipment or musical instruments. You will be advised of applicable rules, restrictions and charges.

Sports Equipment

For transatlantic flights, sports equipment is carried under the category of <u>normal baggage</u> <u>allowance rules/restrictions</u>. For all other flights the following fees/conditions apply:

Pay online prior to day of departure:

(Golf bags, fishing equipment, surf boards, skiing equipment and snowboards only)

Fee of €25 / £17 / AED104 one-way**

Pay at the airport on day of departure:

*Bicycles: A maximum of six pre-booked bicycles may be carried on each aircraft. Bicycles departing Amsterdam airport must be boxed or bagged. These can be purchased at the airport.

*Sports guns are carried only under the following conditions:

- Sport Guns are to be dismantled.
- Sports Guns when dismantled are carried only as checked baggage.
- Sport Guns, ammunition and cartridges must be packed separately from other baggage.
- Sport Guns, ammunition and cartridges must be available for inspection by security.
- Ammunition is limited to 5kg per passenger and must be packed in containers of Wood, metal, or fireboard with the contents protected against any movement.
- Subject to an extra charge for flights within Europe.
- **The flat charge is based on a maximum permitted weight of 15 kilos. If the sports item weighs in excess of this 15 kilos, then a charge of €8/£5 per kilo will apply to this additional weight.

Musical instruments

Small instruments may qualify as hand baggage. Medium sized instruments may be carried in the cabin if the passenger purchases an individual seat for the instrument.

The cabin or hand luggage allowed onboard consists of 1 piece, the maximum permitted measurements of which (56cm X 45cm X 25cm) do not exceed 115 cm in total (45") and which has a total weight of under 10 kg (22 lb).

On top of the applicable allowance (i.e. checked-in hold luggage), all passengers may carry the following items in the cabin, under their own responsibility and at no extra cost:

A lady's ladies' handbag or a small briefcase A coat, cape or travel blanket An umbrella or a walking stick A pair of crutches

A small camera / video camera or a pair of binoculars

A portable cot or a fully folding pushchair, which, duly labelled, would normally be carried in the luggage hold without charge

A laptop computer

Hand luggage should be placed in the overhead lockers or under the passenger's seat. It is therefore strictly necessary that it does not exceed the measurements indicated above.

1 piece of luggage, the maximum permitted measurements of which (56cm X 45cm X 25cm) do not exceed 115 cm in total (45") and which has a total weight of under 14 kg (31 lb).

Firearms and Ammunition

Ammunition (cartridges for firearms) for sporting purposes and packed in a secure manner (Division 1.4 S), in quantities which do not exceed 5 Kg in gross weight per passenger and for personal use, excluding ammunition with explosive or incendiary missiles. The permitted quantity for more than one passenger should not be grouped in one or more parcels.

Restricted Articles:

For security reasons, it is forbidden to carry onto the aircraft objects such as scissors and knives or any kind of sharp items. Such objects must be checked in with hold luggage and never carried in hand luggage. Additionally, passengers may not transport articles that international regulations class as dangerous goods, either in hand luggage or as checked-in luggage. Such articles include:

Explosives, ammunition, fireworks, flares, material for expeditions, security briefcases containing fireworks and materials for fireworks in general.

Compressed, liquid, refrigerated liquid or dissolved gases, whether inflammable, toxic, or non-inflammable and non-toxic, such as: aerosols, extinguishers, breathing devices, oxygen bottles for diving, cryogenic liquids, bottles with cooling gases and compressed gas cylinders in general. Flammable Liquids and Solids, such as fuel, or equipment containing fuel (camping or filming equipment, etc.), adhesives, solvents, paint, varnish, torches, matches, cigarette lighters and inflammable substances in general, either due to them being autoreactive or spontaneously combusting.

Oxidizers and Organic Peroxides, such as oxygen generators.

Toxic or Infectious Substances, such as incapacitating devices, samples for diagnosis, vaccines, insecticides and weed killer

Radioactive Material, such as pharmaceutical products containing radioactive isotopes. Corrosives, such as acids, alkalis, devices containing mercury, storage batteries and devices operated electrically using batteries.

Other Hazardous Items, such as first aid kits, ferro-magnetic material, dry ice and car batteries.

Such articles may only be carried as air cargo (*), although passengers may transport some of them under certain restrictions. Dangerous goods that passengers may transport

The free baggage transportation allowance shall be classified into different categories in accordance with the prices established for each of the different ticket rates. Please, see below.

Every passenger purchasing a ticket shall be entitled to the free transportation of a certain quantity of personal belongings that we call luggage allowance and that shall vary depending on the price paid for the ticket.

Economy class and other special tariffs within the economy compartment are entitled to carry 20 kilos of luggage allowance, while business class allows 40 kg baggage in domestic flights and 30 kg in european and intercontiental flights. The luggage allowance for minors and infants is 10 kilos.

As an exception to this rule, flights to the Dominican Republic and to Cancun allow two pieces of luggage/64 kilos of maximum total weight. Flights to the USA (operated by Continental Airlines) allow two pieces of luggage/45 kilos of maximum total weight (100lb)

Each passenger is allowed to carry one piece of luggage not weighting more than 9 kilos in economy class and 12 kilos in business class. The maximum size of the luggage piece is 55 x 35 x 25 cm. Passengers are also allowed to carry the following items free of charge:

- a).- A handbag, wallet or purse adequate to the normal cloths worn for the trip, as long as they are not used as a container for the transport of articles that would receive the consideration of luggage if carried somewhere else.
- b).- A reasonable quantity of reading items for the flight.
- c).- An overcoat, coat or travel rug.
- d).- An umbrella and/or a walking stick.
- e).- A small photographic camera and/or a pair of binoculars.
- f).- A basket/crib for the transportation of babies.
- g).- Children's food for consumption during the flight.
- h).- A folding wheelchair and/or a pair of crutches or any other prosthetic items as long as they are strictly necessary for the passenger.
- i).- Sporting equipment.

All these articles shall be transported free as a separate service from the normal luggage allowance as long as passengers carry them with them in the guest cabin during the flight, exception made for wheelchairs belonging to wheelchair-bound passengers and baby carriages and strollers. These must be checked in beforehand and shall be transported in the cargo compartment of the aircraft, though passengers can arrange for the use of their wheelchairs and baby carriages until boarding the aircraft, when they shall give them to the Air Europa Coordinator to be taken into the cargo compartment of the aircraft.

- (d) Firearms and ammunition, other than for hunting or sporting purposes are prohibited from carriage as Baggage. Firearms and ammunition for hunting purposes may be accepted as Checked Baggage if they are unloaded with the safety catch on, and suitably packed. Carriage of ammunition is subject to the ICAO and IATA Dangerous Goods Regulations, as specified in paragraph (a) here above;
- (e) Weapons such as antique firearms, swords, knives and similar items may be accepted as Checked Baggage, at Air Europa discretion, but will not be permitted in the aircraft passenger cabin

Article 3 of the Commission Regulation (EC) No 68/2004 lays down the measures for the implementation of the common basic standards on aviation security that must be observed by both Members States and air companies registered in them, in order to avoid articles that are prohibited from being carried by passengers into restricted areas of airports and on board aircrafts. Due to the continuous evolution of the type of arms, objects, materials and substances that can be used to commit unlawful acts, the list of prohibited articles can never be exhaustive and shall always be subject to subsequent amendments as new items or forms of threat are detected that jeopardize the safety of aircraft operations. The list of prohibited articles should be accessible to the public and should set out separately articles are prohibited from being carried by passengers into restricted areas and the cabin of an aircraft and those articles that are prohibited from being carried in baggage intended for stowage in the aircraft's hold. The list of prohibited articles on passenger aircrafts shall be available at check-in desks.

Passengers are not allowed to carry the following articles to restricted areas and to the cabin of aircrafts:

a) Guns, Firearms and Weapons.

Any object capable, or appearing capable, of discharging a projectile or causing injury, including:

All firearms (Pistols, Revolvers, Rifles, Shotguns etc.) Replica and imitation firearms. Component parts of firearms (excluding telescopic sighting devices and sights). Air pistols, rifles and pellet guns. Signal flare pistols, starter pistols, toy guns of all types. Ball Bearing Guns, Industrial Bolt and Nail Guns.

Cross-bows, catapults and slingshots. Harpoon and spear guns. Animal humane killers. Stun or shocking devices, such as cattle prods, ballistic conducted energy weapons (taser). Lighters shaped like a firearm.

b) Pointed/edged Weapons and Sharp Objects.

Pointed or bladed articles capable of causing injury, including:

Axes and hatchets, arrows and darts. Crampons (article used for walking on ice in mountain climbing, that is stuck to the shoe or boot). Harpoons and spears used in underwater fishing. Ice axes and ice picks used in mountain climbing. Ice skates. Lockable or flick knives with blades of any length. Knives, including ceremonial knives, with blades of more than 6 cm, made of metal or any other material strong enough to be used as a potential weapon. Meat cleavers. Machetes. Open razors and blades (excluding safety or disposable razors with blades enclosed in cartridge). Sabres, swords and swordsticks. Scalpels. Scissors with blades more than 6 cm in length. Skis and walking/hiking poles. Throwing stars used in martial arts. Tradesman's tools that have the potential to be used as a pointed or edged weapon, such as 1 drills and drill bits, box cutters, utility knives, all saws, screwdrivers, crowbars, hammers, pliers, wrenches/spanners, blow torches.

c) Blunt instruments.

Any blunt instrument capable of causing injury, including:

Baseball and softball bats. Clubs or batons rigid or flexible, such as Billy clubs, blackjacks, nightsticks and baton. Cricket bats. Golf clubs. Hockey sticks. Lacrosse sticks. Kayak and canoe paddles. Skateboards. Billiard, snooker and pool cues. Fishing rods. Martial arts equipment, such as knuckle dusters, clubs, coshes, rice flails, num chucks, kubatons, kubasaunts.

d) Explosives and flammable substances . Any explosive or highly combustible substances which poses a risk to the health of passengers and crew or the security / safety of aircraft or property, including:

Ammunition. Blasting caps. Detonators and fuses. Explosive and explosive devices. Replica or imitation explosive material or device. Mines and other explosive military stores. Grenades of all types. Gas and gas containers, such as butane, propane, acetylene, oxygen in large volume. Fireworks, flares in any form and other pyrotechnics (including party poppers and toy caps). Non safety matches. Smoke generating canisters or cartridges. Flammable liquid fuel, such as petrol / gasoline, diesel, lighter fluid, alcohol, ethanol. Aerosol spray paint. Turpentine and paint thinner. Alcoholic beverages exceeding 70% by volume (140% proof).

The following articles shall not be placed in hold baggage:

Explosives, including detonators, fuses, grenades, mines and explosives. Gases: propane, butane. Flammable liquids, including Gasoline, methanol. Flammable solids and reactive substances, including magnesium, firelighters, fireworks, flares. Oxidizers and organic peroxides, including bleach, car body repair kits. Toxic or infectious substances, including rat poison, infected blood.

Radioactive material, including medicinal or commercial isotopes. Corrosives, including mercury, vehicle batteries. Vehicle fuel system components, which have contained fuel, such as turpentine and paint thinners.

Sporting equipment includes bicycles, skis (water or snow), diving equipment, golf clubs, surfboards, delta wings, and hang gliding equipment.

It is advisable for this equipment to be properly crated in a suitable bag or a box. As a minimum requirement, prominent parts of this equipment shall be removed and protected to avoid damaging other pieces of luggage.

Bicycle wheels, balls or any other inflatable item shall be deflated before check-in.

This equipment is subject to an additional fee, for they are not included in the allowance. As an exception, golf clubs are included in the luggage allowance only in national regular flights, and shall be weighted together with the normal luggage. Only in the case of excess luggage, a fee shall be applied for the extra kilos. This fee shall depend of the type of flight.

Diving equipment include cylinders, which shall be emptied before check in and carried in the cargo compartment of the aircraft.

Transportation of ammunitions must be pre-notified.

The following packing conditions must be met for ammunitions:

- It must be packed separately from the firearm.
- It must be packed in a strong outer container made of wood, metal or fiberboard
- It must be protected, inside the container, against shock and secured against any movement
- It must be packed in a way that it cannot function accidentally.

- Star Alliance Gold Customers (including Airpoints Gold and Gold Elite) are permitted two pieces with the same conditions as above.

8.3.3 Weapons such as antique firearms, swords, knives and similar items may be accepted as Checked Baggage, but will not be permitted in the cabin of the aircraft.

Passengers may carry 1 gas lighter on their person.
The following may only be carried in baggage that has been checked in:

☐ Knitting needles

The list of prohibited items is not final and can be added to at time. Additional regulations may apply to certain flights. Please also note the IATA regulations on hazardous goods. The airline can provide these regulations on request.

- 8.4 Firearms
- 8.4.1 We do not carry firearms and ammunition other than sporting guns or ammunition.
- 8.4.2 If you want us to carry sporting guns or ammunition you must get our permission before you check in. If you do not, we may decide not to carry them.
- 8.4.3 All sporting guns and ammunition must be carried as checked baggage and we will not allow you to take them into the aircraft cabin.
- 8.4.4 All sporting guns carried as checked baggage must be unloaded, have the safety catch on and be suitably packed.
- 8.4.5 Carrying of sporting guns and ammunition is covered by the ICAO Technical Instructions and the IATA Regulations referred to above.
- 8.4.6 You must make sure that you have all the documents you need for the sporting gun and ammunition to be carried. If you do not, we may decide not to carry them.
- 8.5 Dangerous items you must not take with you onto the plane
- 8.5.1 You must not take any item into the aircraft cabin if we tell you that we reasonably believe that its presence there would affect the safety and security of the aircraft or any person in it.
- 8.5.2 You must not take antique, toy or replica guns into the aircraft cabin.

- 8.5.3 You must not take swords, knives, archery bows, arrows or similar weapons into the aircraft cabin.
- 8.5.4 We may tell you either to check in items referred to in Clauses 8.5.1, 8.5.2 or 8.5.3 as checked baggage or refuse to carry them altogether.
- 8.6 Fragile or perishable items must not be packed in baggage, checked into the hold (including the last on first off ("LOFO")).

You must not include in your checked baggage fragile or perishable items or items of special value such as but not limited to

Money; Jewellery; Precious metals; Computers; Personal electronic devices; Share Certificates, Bonds or other valuable documents;

Business documents or samples; or

Passports and other identification documents.

8.7 We are not responsible for loss of or damage to forbidden items.

If, despite the fact that an item is forbidden under Clauses 8.3, 8.5 or 8.6, you included it in your baggage, we will not be responsible for any loss or damage caused to it.

- Checked baggage is left at the check-in desk to be carried by the airline.
- The baggage travels on the same flight as the passenger.
- Officials might need to open your checked baggage after security screening, if they suspect it contains any dangerous materials or articles. A baggage strap around the suitcase prevents it from opening. An insurance is also always recommended to cover any possible damage caused to the baggage during handling.
- A Priority tag is attached to the baggage of Business Class passengers and Finnair Plus Platinum, Gold and Silver members to assure swift delivery at arrival.
- The maximum weight of a single bag on a Finnair flight may not exceed 32 kg or 70 lb. (for example a suitcase shareed by two passengers travelling together). - Children under 2 years of age (infants) without a reserved seat may bring 10 kg or 22 lb. of baggage and a folding pushchair.
- Also note that a single bag may not weigh more than 32 kg or 70 lb. (for example a suitcase shared by two passengers travelling together).

Firearms and Ammunition

Sporting and hunting guns are accepted as checked baggage only in the aircraft hold. The firearm must be unloaded and suitably packed so that it will not be damaged during the flight. To prevent breakage, hardshell cases are recommended for packing the firearm. Information of the firearm shall be given to the airline at the time of reservation. It is the duty of the passenger to ensure that all the required licenses have been obtained and that all import regulations and restrictions of the destination country are observed.

Only securily packed ammunition for small arms in Division 1.4S will be accepted for carriage. The amount of ammunition must not exceed 5 kg or 11 lb. per passenger. Allowances for more than one passenger cannot be combined into one or more packages. The ammunition may be transported in the same container as the firearm, if there is a special compartment provided for the ammunition, but there shall be no ammunition in the gun itself.

Restricted Articles:

Materials prohibited on flights:

The following materials and goods may never be taken on flights:

- Explosives such as fireworks, flares, torches, toy guns and caps.
- Frammable aerosol gases (over 2 kg or 4.4 lb. or 2 litres), camping gas containers.
- Pepper or gas spray weapons or atomisers intended for self-defence, carbon dioxide cartridges for soda siphons, cigarette lighter refills, butane gas cylinders, insecticides.
- Easily ignited gases and materials, paints, thinners, solvents, fire-lighters.
- Oxidizing agents, bleaches.
- Organic peroxides, resins or poisons such as arsenic, cyanide, tear gas.
- Infectious materials such as viruses, blood samples and bacteria that could affect human beings or animals.
- Radioactive substances and instruments containing radioactive isotopes.
- Corrosive substances such as acids, alkalis, mercury or mercury-filled thermometers, barometers.
- Alcoholic beverages with alcohol content exceeding 70% by vol.
- Lighters are not accepted on flights to and from US. On domestic flights within US, a Zippo lighter is allowed in the checked baggage if it is packed in an officially approved

box specially made for Zippo by Otter Box. On flights from and within US, passengers may carry up to four books of strike-on-cover matches on their person.

Materials that can be brought onboard subject to restrictions:

Special care must be taken when transporting and packing these materials and it is recommended that you obtain further information when you book, either via a travel agent or directly from the airline.

- Ammunition for sports weapons, up to a maximum of 5 kg or /11 lb. per passenger, packet firmly in boxes. Permission for transport must be obtained in advance from Finnair.
- Personal hygiene and medicinal products, for example. hairspray, which incorporates an aerosol, up to a maximum of 2 kg or 4.4 lb. or 2 litres per passenger either in carry-on baggage or checked baggage. The unit size may not exceed 0.5 litre or kg or 1.1 lb. Mosquito repellent that is applied on your skin, is allowed either in carry-on baggage or checked baggage.
- On departure from Finland only one lighter or one packet of matches intended for personal use is allowed on one's person and not packed into checked baggage or carry-on baggage. They are forbidden in carry-on baggage and in checked baggage. Highly flammable "strike anywhere" matches are totally forbidden. The carrying of cigarette lighter refills is prohibited. No lighters are accepted on flights to and from US.
- One catalytic curler per passenger either in carry-on baggage or checked baggage. Its use is prohibited during the flight.
- A small mercury thermometer is permitted in carry-on baggage, if it is in durable packaging.
- Dry ice may be carried in carry-on baggage up to 2 kg or 4.4 lb. per passenger.
- Passengers with an external pacemaker must contact the flight physician prior to travelling.
- A maximum of 5 litres of alcoholic beverages in retail packaging with an alcohol content of more than 24% but less than 70% by volume, may be transported as carry-on baggage and included in the maximum weight and size limit of carry-on baggage.
- Insulated packagings containing refrigerated liquid nitrogen under special provisions.
- Heat producing articles such as underwater torches (diving lamps) and soldering irons, can be transported in carry-on baggage provided that the heat producing component or energy source has been removed to prevent unintentional functioning.
- Small oxygen and air tanks (under 5 kg or 11 lb.) for medical purposes may be included in checked baggage after obtaining permission from Finnair. Finnair's Flight Physician, Dr Olavi Hämäläinen will be happy to answer any medical questions relating to air transport, tel. +358 9 818 4845.
- The transport of liquids is further limited on flight to and from the US, as well as on all flights departing from an EU country, or from Iceland, Norway or Switzerland. Each container may hold 100 ml (3.5 oz.) and they have to be packed in a transparent, resealable plastic bag of a maximum size of 1 litre. On departure from US the containers may hold 90 ml (3 oz.).
